FESTIVAL RULES

- Artists must be 18 or older.
- Submit 3 high quality photos of your work and 1 booth shot labeled with your name. Email or CD's with images are acceptable.
- Jury fee is due by January 31. Please submit 2 checks: one for the Jury Fee and one for the booth fee.
- The Jury Fee is non-refundable. Booth fee refunds must be requested in writing by January 31.
- No application will be accepted after March 2 at 5:00 p.m.
- Artists acceptance letters will be sent by e-mail after January 31.
- Artists accepted after February 2 will not appear in the event booklet.
- Refunds will not be issued due to inclement weather -- the festival will take place rain or shine.

- Artists shall comply with all applicable rules, ordinances, statues, laws and regulations.
- Artists must use their own means of display including a white, flame-retardant tent. Staking into the pavement will not be permitted. **Tents must be weighted down.**
- Artists may only sell what is approved on the application.
- Displays must be professional and aesthetically pleasing. For sale signs are prohibited.
- All work must be original handcrafted, created and exhibited by the artist. Kits, imports and mass produced items will not be accepted.
- Space for large RV vehicles is limited (*but not guaranteed*) and will be provided on a first come - first serve basis; electricity not provided. Overnight parking is permitted.
- Representatives of the Arts and Culture Advisory Board will visit your booth to review your art pieces, crafts and set-up during regular Festival hours.
- Artists shall remove any articles that are not in compliance with the criteria set forth in the artist application when notified by the City.
- The City reserves the right to remove any questionable artwork from view and close the display without compensation.
- Artists are required to collect the State Sales Tax (6%) and file a report with the Florida Dept. of Revenue.
- **NO BUY / SELL.**
- The approved artist must occupy his or her booth at all times. Booth sitters will be provided for short breaks.

SHOW SET-UP

Friday, March 9th from Noon - 6:00 p.m. or Saturday, March 10th with set-up completed by 8:30 a.m. Artists will not be permitted onto the festival grounds after 8:00 a.m.

SHOW BREAKDOWN

Sunday, March 11th from 5:00 p.m. – 8:00 p.m. Cars are not permitted onto festival grounds until streets are cleared of all pedestrians.

• The City of Pembroke Pines has the right to modify or amend the Art Festival Rules without notice to the artist, as necessary.

PLEASE NOTE: GENERATORS ARE NOT PERMITTED AT YOUR BOOTH!
