- 10 CHILD MINIMUM, 40 PERSON MAXIMUM
- A PRE - PAYMENT OF \$80.00 MUST BE PAID 4 WEEKS PRIOR TO PARTY
- AN ADDITIONAL FEE OF \$25.00 WILL BE CHARGED TO YOUR BILL IF YOUR PARTY LOCATION IS NOT LEFT IN THE CONDITION ORIGINALLY FOUND
- \$8.00 PER CHILD WHICH INCLUDES: USE OF UMBRELLA, MEAL (SLICE OF PIZZA OR HOTDOG, SODA, AND CHIPS), AND PARK ADMISSION
- \$4.00 FOR *EACH* ADULT ATTENDING PARTY
- CHECKS WILL BE ACCEPTED 4 WEEKS PRIOR TO PARTY, IF LESS THAN A 4 WEEK PERIOD REMAINS, **CASH WILL ONLY BE ACCEPTED**
- REMAINING BALANCE MUST BE PAID IN CASH (**NO CHECKS ACCEPTED**)
- NO OUTSIDE FOOD ALLOWED *ONLY* THE BIRTHDAY CAKE
- CONCESSION STAND IS OPEN TO PURCHASE MORE FOOD
- AT THE END OF THE 2 HOUR SESSION FEEL FREE TO STAY AND ENJOY THE PARK

- IN-DOOR AIR CONDITIONED FACILITY WITH KITCHEN AREA
- 20 CHILD MINIMUM, 99 PERSON MAXIMUM
- AN ADDITIONAL FEE OF \$25.00 WILL BE CHARGED TO YOUR BILL IF YOUR PARTY LOCATION IS NOT LEFT IN THE CONDITION ORIGINALLY FOUND
- A PRE - PAYMENT OF \$100.00 MUST BE PAID 4 WEEKS PRIOR TO PARTY
- \$10.00 PER CHILD WHICH INCLUDES: USE OF HALL AND PARK ADMISSION  
\$12.00 PER CHILD WHICH INCLUDES: USE OF HALL, PARK ADMISSION AND MEAL (SLICE OF PIZZA OR HOTDOG, SODA, AND CHIPS)
- \$4.00 FOR *EACH* ADULT ATTENDING PARTY
- CHECKS WILL BE ACCEPTED 4 WEEKS PRIOR TO PARTY, IF LESS THAN A 4 WEEK PERIOD, **CASH WILL ONLY BE ACCEPTED**
- REMAINING BALANCE MUST BE PAID IN CASH (**NO CHECKS ACCEPTED**)
- OUTSIDE FOOD IS ALLOWED ALONG WITH THE BIRTHDAY CAKE (**ALL OUTSIDE FOOD MUST BE CONSUMED INSIDE OF HALL--NO OUTSIDE FOOD ALLOWED ON POOL DECK**)
- CONCESSION STAND IS OPEN TO PURCHASE MORE FOOD
- AT THE END OF THE 2 HOUR SESSION FEEL FREE TO STAY AND ENJOY THE PARK (*ALL OUTSIDE FOOD, COOLERS, ETC. MUST BE REMOVED FROM THE FACILITY AFTER RENTAL SESSION*)
