**Subject 1 has been identified as the shooter. Investigators have not been able to complete their interview with subject 2 as of this time. Any charges related to this incident are pending the outcome of the investigation and not been determined at this time. This is an active investigation. No further information is being released at this time.**

**Preliminary investigation has revealed that there was a traffic related incident that occurred in the 15800 block of westbound Pines Blvd. The incident escalated to a physical confrontation at which time one subject discharged a firearm striking the other subject. The gunshot victim was transported to Memorial Regional Hospital in stable condition with non life threatening injuries. One subject has been detained and is being questioned by investigators. There were independent witnesses to this incident. There are no subjects at large. Identification of the subjects is being withheld at this time pending notification of next of kin. A PIO will be available in the Walgreens parking lot, 15911 Pines Blvd, until 6pm.**
