*****UPDATE – August 27, 2020*****

On May 23, 2018, Tyler Rowe was the victim of a homicide inside of the Gatehouse apartment complex by Javayne McDonald. McDonald was arrested shortly after the incident, and remains in custody at the Broward County Jail.

During the course of the investigation, John Salazar was identified as a second suspect involved in this incident. With the assistance of the Sunrise Police Department, Salazar was subsequently arrested on August 25, 2020 on an active arrest warrant for homicide and transported to BSO

On Thursday, May 31, 2018, investigators from the Pembroke Pines Police Department secured a signed arrest warrant for Javayne McDonald in connection with the homicide of Tyler Rowe that occurred on Thursday, May 23rd 2018. Javayne McDonald was taken into police custody at approximately 7:18pm on today's date (June 2nd 2018) in Hollywood, Florida.

This case remains an active criminal investigation. As such, the information that can be provided at the present time is limited. Once additional information is available, this media release will be updated.

*****Initial Media Release - May 23, 2018*****

Pembroke Pines Police Officers responded to Memorial Hospital Pembroke, in response to a call of a gunshot victim that had been dropped off at the emergency room. When they arrived, officers were advised by emergency room staff that lifesaving efforts were not successful, and the victim had been declared deceased. His identity will not be released until next of kin is notified.

At present, detectives are actively investigating leads in an effort to find the suspect. It is possible that the incident occurred in the parking area of the Gatehouse Apartment Complex. Once additional information is available, this media release will be updated.
