Following an extensive investigation which involved multiple state and federal law enforcement agencies, the Pembroke Pines Police Department have identified three suspects pertaining to the November 9, 2024, school threat made against Somerset Academy.

15-year-old Logan James Gollinger of New York and 14-year-old Juan Antonio Banos of Michigan were both identified as suspects and face felony and misdemeanor charges.

Juan Antonio Banos surrendered himself on Wednesday, January 15, 2025, and is being held by the Florida Department of Juvenile Justice.

Banos' charges include Threat to Throw, Project, Place or Discharge Any Destructive Device (FSS 790.162), Unlawful Use of a Two-Way Communications Device (FSS 934.215), Threats or Harassment (FSS 836.12), and Disruption of an Educational Institution (FSS 877.13, FSS 777.011).

Logan James Gollinger was arrested by the New York State Police on January 3, 2025, and remains in state custody. An extradition hearing is scheduled on Thursday, January 16, 2025, to determine when Gollinger will arrive in Florida.

Gollinger's charges include Threat to Throw, Project, Place or Discharge Any Destructive Device (FSS 790.162), Unlawful Use of a Two-Way Communications Device (FSS 934.215), and Disruption of an Educational Institution (FSS 877.13, FSS 777.011).

In addition, Gollinger's mother was taken into custody on January 3, 2025, in New York. Although Elizabeth Smith was released on bond, it is anticipated that she will surrender to Pembroke Pines Police on or before January 24, 2025, for knowingly instructing her son to delete evidence related to this investigation.

Elizabeth Smith faces one felony charge of Solicitation to Commit Tampering with Physical Evidence (FSS 918.13, FSS 777.04(2)(d)).

The Pembroke Pines Police Department will fully investigate all threats to cause harm at any school campus within our community. Investigators followed every lead, uncovered evidence, and collaborated with law enforcement partners to include the Broward Sheriff's Office, the Florida Department of Law Enforcement, the New York State Police, the Federal Bureau of Investigation, the Bureau of Alcohol, Tobacco, Firearms and Explosives, and the State Attorney's Office.

Although Gollinger and Banos used multiple techniques to conceal their identities, police officers identified and arrested each person for their role in threatening to cause harm at a school campus.

We remind parents to please speak to your children about the seriousness of these crimes, and to pay careful attention to your children's online activities.

This remains an active and on-going investigation, and additional charges for each juvenile may be forthcoming.

On Saturday, November 9, 2024, the Pembroke Pines Police Department was alerted to a suspicious call that was received by the Broward Sheriff's Office non-emergency dispatch line. A male caller identified himself as a student of Somerset Academy (20803 Johnson Street) and made threats towards the school and police. The caller provided a name and claimed that the violence would occur within the week of November 11th – November 15th.

The Pembroke Pines Police Department's Threat Assessment Team was immediately deployed and began investigating the source of the call. Investigators determined that the name provided by the caller did not belong to a current or former student of Somerset Academy. To increase campus security, our department worked together with Somerset Academy's school administration to create a safety plan and assigned extra police officers to the campus.

Multiple persons of interest were identified, including individuals from out of state. Following preliminary interviews, our department has not located any evidence to suggest that the threat was credible. It appears that the call was a hoax. While our investigation remains active and on-going, criminal charges may be pending. Our department will release additional information as it becomes available.

Making threats of this nature is a serious offense and the Pembroke Pines Police Department will fully investigate any report of violence directed at any schools located within the City of Pembroke Pines. We urge all parents to please speak with their children about the severe consequences of making threats of violence toward a school campus, students, or staff.
