

PUBLIC INFORMATION MEETING

PEMBROKE ROAD EXPANSION AND MIRAMAR PARKWAY EXTENSION

Broward County, Florida

You are invited to a Public Information Meeting to discuss the Pembroke Road Expansion and Miramar Parkway Extension project. This meeting is to provide project information and solicit public input about some design aspects of the project. This public meeting will be offered in two different formats at two different times during the same evening: virtual and in-person. Project information will be available for public viewing and representatives will be available to answer questions. Questions and comments may be submitted prior to the meeting by emailing the Project Manager or on the project website. The virtual presentation will start at 5:00 p.m. and the in-person meeting will start at 6:30 p.m. Both presentations will be followed by a question-and-answer session. PROPOSED IMPROVEMENTS

Segment A

Reconstruct Pembroke Rd. from a 2 lane to 4 lane divided roadway with buffered bike lanes and sidewalks or multi-use paths.

Segment B

Extend Pembroke Rd. as a 4 lane divided road from SW 196th Ave. to US-27 with buffered bike lanes and sidewalks or multi-use paths and install a signal at the intersection with US-27.

Segment C

Extend Miramar Pkwy. as a 2 lane roadway with buffered bike lanes and sidewalks or multi-use paths from SW 192nd Terr. to intersect with the extension of Pembroke Rd.
