Make check payable to the *City of Pembroke Pines*. Entries will be accepted by mail or delivered to **Studio 18 in the Pines**, Monday-Friday between the hours of 9:00am and 5:00pm and Saturday 10am to 2pm.

APPLICATION DEADLINE: No application will be accepted after **Friday, September 28, 2018 at 5pm.**

Artists will be notified of their acceptance via e-mail by **Tuesday, October 2nd, 2018.**

Accepted entries will be exhibited at Studio 18 in the Pines from **Friday, October 12th to Thursday, November 8th, 2018.**

PRIZE CATEGORIES

\$500 Best of Show	\$200 Best Digital Art
\$200 Best Drawing	\$200 Best Mixed Media
\$200 Best Painting	\$200 Best Photography

In addition to selecting winners in each category above, the Art and Culture Advisory Board will select a **“Festival Poster Winner”** from all of the submissions to the Art Competition.

The Festival Poster Winner receives

- \$200 cash prize
- The winning poster will be on the cover of the Art Fest in the Pines booklet.
- FREE 10x10 space, and tent at the **21st Annual Art Fest in the Pines** held on March 9th & 10th, 2019 at the **Charles F. Dodge City Center.**

Competition results will be decided by a panel of selected qualified art judges

GUIDELINES

• The City of Pembroke Pines has the right to modify or amend the Art Competition guidelines without notice to the artist, as necessary.

• Artists must be 18 or older to participate.

• All artwork must be **ORIGINAL** and created by the artist. Artists shall comply with all applicable rules, ordinances, codes, statues, laws and regulations.

• Artists may submit more than 3 pieces of artwork. *(will require additional application and entry fees)*
Entry fees are non-refundable.

• Photographs must be 4x6. Poor quality photographs will not be considered. Photographs must be clearly labeled on the back with the following:

- **Artists Name**
- **Title**
- **Category & Medium(s) used**
- **Phone Number**
- **Dimensions**
- **Price – if applicable**

• The Jury Board reserves the right to change your category if you do not adhere to the descriptions.

• 2-D artwork **MUST** be wired and ready for hanging and not exceed **40”x30”**. Glass is **NOT** permitted on framed paintings. Acrylic is acceptable.

DROP-OFF FOR INSTALLATION: 9am to 3pm on Friday, October 5th, 2018 at Studio 18 in the Pines.

Artists must submit a signed and notarized Art Exhibition Agreement on drop-off date. For your convenience a Notary will be onsite.

OPENING RECEPTION: Friday, October 12th, 2018 at Studio 18 in the Pines from 7:00pm to 9:00pm.

Artists must agree to have photographs taken of their entries for the purpose of promoting the Art Competition.
